

Celebrating the 30th Anniversary of the Violence Against Women Act (VAWA)









GFWC was honored to be present at the White House in celebration of the 30th anniversary of the Violence Against Women Act. President Biden authored the first VAWA in 1994 as Chairman of the Senate Judiciary Committee and has been involved with every reauthorization since then. We are proud to join Members of Congress, key national advocates, and survivors to celebrate progress and acknowledge the challenges ahead.


Highlights included meeting President Joseph Biden and Department of Interior Secretary Deb Haaland. Interior Secretary Haaland is the first Native American to serve as a cabinet secretary and was the first Native American woman to serve in Congress. She has led efforts to address domestic and sexual violence impacting indigenous women and children.

GFWC International President Suellen Brazil also met up with Rosie Hidalgo, the Director of the Office on Violence Against Women at the Department of Justice. Hidalgo was a featured speaker at the GFWC Board of Directors Meeting in August 2022.

GFWC is committed to supporting women and victims of domestic and sexual violence under the banner of our Signature Program.

Smash the Stigma

On September 10 we recognized World Suicide Prevention Day. Every year, it is a day to shine a light on mental health and the importance of building community, spreading hope, and smashing the stigma associated with mental illness. It is a day to remind people that it is ok to not be ok, that asking for help is a sign of strength, that hope is out there, and that suicide should never be an

option. I write this from my personal experience as a mother who had no idea that her daughter was struggling with depression and self-harm and as someone who has been impacted by suicide loss.

In 2016, I founded <u>The Yellow Tulip Project</u> with my daughter to remind young people that their voices matter and that each of us makes a difference in this important space. What started with one Hope Garden filled with yellow tulips in Portland, Maine, has become a national and international momentum with community groups from Maine to California to Edinburgh, Scotland, getting involved, getting their hands dirty, and planting gardens of Hope. As a 2024-2026 GFWC Honorary Chairman in the Health & Wellness CSP area, I am honored to work with GFWC's incredible community network of volunteers to spread awareness and hope around such an important topic.

Clearly educate and communicate the value of being a member of your club and GFWC. Review membership benefits regularly based on member feedback and adjust accordingly. Report Due: January 2

January, February, March: Focus on Diverse and Inclusive Programming
Be sure you consider all members' needs when organizing your calendar of
events and activities. Ensure club programs are accessible and open to a
diverse membership base. Report Due: April 1

April, May, June: Focus on Professional Development

Offer leadership workshops, seminars or training that could contribute to your members' personal growth. Provide access to tools and resources that can help them advance their careers, such as project management and public speaking. Report Due: July 1

The Circle of Health



Good health first and foremost is nutrition; everyone should strive to eat a nutritionally balanced diet. Our National Day of Service focus on food insecurity highlights that some may be starving and welcome anything to eat while some overconsume and likely, do not have a balanced diet. Both cases may contribute to poor health. As we move clockwise, physical exercise improves health and lowers the risk of heart disease and diabetes. Next, support from family and friends (including pets) is imperative to emotional well-being. Sleep is key to physical and mental health. Lack of food, physical exercise, emotional support, and sleep make it difficult to manage stress. On the other hand, some who do well in diet and physical activity may still have difficulty sleeping. To sum it up **balance** is the key to Health & Wellness.

The 2024-2026 Health & Wellness Community Impact Initiative is the "Caregivers Circle." Like the circle in the diagram, those who are taking care of a family member or friend require support and may be hesitant to reach out. There are many ways that we, as GFWC members, can establish "Caregiver Circles" in our communities. We are the connectors bringing together resources to provide emotional support and friendship.

September: Adolescent Mental Health, Childhood Cancer, Leukemia & Lymphoma, Ovarian-Prostrate-Thyroid Cancers.

October: Breast & Liver Cancer, Minority Mental Health, Sudden Cardiac Arrest.
