GFWC Bylaws

By now, I hope you have seen the *Call* to the GFWC Convention, June 6-9, in Atlanta, and have read the proposed amendments to the GFWC Bylaws. Please study these and bring your *Call* pages to the Convention so that you have the proposals in front of you when they are discussed. They will also be projected on the screen.

Our bylaws state, "These bylaws may be amended at any annual convention by a two-thirds vote of those present and voting, provided the proposed amendment has been appended to the call to the convention."

A two-thirds vote means at least two-thirds of those entitled to vote, excluding blanks (unmarked ballots) or abstentions, have voted yes. For example:


If 100 votes are cast, a two-thirds vote is 67*

If 101 votes are cast, a two-thirds vote is 67*

If 102 votes are cast, a two-thirds vote is 68.

*You cannot have a fraction of a member, which is why 100 votes, and 101 votes, are the same.

Take time to read the proposed amendments, and I hope you join us to cast your vote on important decisions that shape GFWC's future. See you in Atlanta!

Our clubs are continually working on recruiting new members and bringing back those who have stepped away for various reasons. This will help us grow the many volunteers we need to bring GFWC projects to every area of Kansas.

One of the projects many GFWC Kansas clubs are working on is creating Blessing Boxes. The boxes cater to various needs by supplying essential items, including books, food, hygiene products, writing paper, pencils, and pens, to support struggling communities.

Kansas will offer training in all aspects of GFWC membership. We will be training members on the ins and outs of positions held in local clubs. There will be large-scale training for our members available at our State Convention held in April.



Legislative Corner

To encourage participation in the democratic process, this monthly column aims to inform members about current legislation and programs that are germane to the GFWC Resolutions. It also highlights important actions of Congress and the White House, and provides follow-up information about GFWC Legislative Action Alerts.

GFWC Legislative Priorities Set for 2025: In early March, the GFWC Executive Committee approved the <u>2025 Legislative Priorities</u> and visited their respective Senate offices to advocate for increased funding and program resources for survivors of domestic and sexual violence, human trafficking, and child sexual exploitation. During the visits, several congressional staff reaffirmed that hearing from local constituents does make a difference. We will continue to utilize the <u>GFWC Legislative Action Center</u> to communicate to Congress to express our priorities. If you are not a member, please join. Our united voices matter!

FY 2025 Federal Appropriations Finally Finished: With the clock running out and facing a government shutdown, Congress completed the FY 2025 appropriations process on March 14 by enacting a Continuing Resolution to September 30, the end of the 2025 federal fiscal year. The measure provides funding at the FY 2024 levels for the remainder of FY 2025, except for increases in defense, homeland security, veterans' affairs, and the Federal Aviation Administration and decreases in foreign aid, the IRS, and EPA climate programs.

A priority for GFWC, additional funding was included in the FY 2025 Continuing Resolution for the Crime Victims Fund authorized by the Victims of Crime Act. This supports local domestic violence shelters, rape crisis centers, child advocacy centers, and other child sexual abuse treatment programs.

Federal funding for global vaccines is being debated within the Administration's plans to reduce foreign aid and transfer programs to the State Department. Where funding levels for specific programs are not identified in the Continuing Resolution, the Administration will have discretion regarding spending. The White House's FY 2026 proposed budget is expected in April.
